CONSENT DECREE

Plaintiffs iWALK, INC. and MASSACHUSETTS INSTITUTE OF TECHNOLOGY (collectively, "Plaintiffs") and Defendants ÖSSUR HF and ÖSSUR AMERICAS, INC. (collectively, "Össur") (Plaintiffs and Össur are collectively referred to as the "the Parties") have agreed to settlement of this action upon the terms and conditions set forth below.

THEREFORE, on the joint motion of the Parties, it is hereby ORDERED, ADJUDGED, and DECREED as follows:

1. This action is hereby reopened for purposes of entering this Consent Decree.
2. Plaintiffs stipulate, and the Court finds, that Össur's Power Knee, as currently sold (the "Power Knee"), does not infringe any claim of U.S. Patent No. 5,650,704.
3. Plaintiffs covenant never to sue Össur for patent infringement for making, using, having made, selling, offering for sale, or importing, the Power Knee.
4. The Parties' claims and counterclaims with respect to U.S. Patent No. 5,650,704 are hereby dismissed with prejudice.
5. The Parties shall bear their own legal fees and costs.
